Payment of Tuition for all Child Development Programs and Grade School Care:

***All tuition is due one payment in advance.**

***No tuition or registration fee will be refunded.**

***A fee of \$2.00/minute will be charged to accounts if the child is picked up after 6:00pm. Exceptions are: severe weather or an accident. Notify the office if this is the case.**

Weekly Tuition is due one week in advance and is delinquent after 6:00pm on Monday of the week for which payment is due. A 10% finance charge will be added to accounts as of Monday, 6:00pm.

Bi-weekly Tuition is due one week in advance and is delinquent after 6:00 pm on the first Monday of the weeks for which payment is due. A 10% finance charge will be added to accounts as of Monday, 6:00pm.

Monthly Tuition is due on the first Monday of each month. Tuition is billed based on the number of Mondays in a month. Some monthly charges will be for 4 weeks and others 5 weeks. A 10% finance charge will be added to accounts after 6:00pm the first Monday of each month.

Return Check Fee

All return checks are subject to a service charge of \$30.00 or the maximum allowed by law. Collection costs and all penalties served by law will also be assessed.

Special Summer Vacation Tuition Feature

During the months of June, July, and August half-priced tuition payment for family vacation is possible. In order to receive half-price tuition, submit a written notice to the office at least one week in advance, stating the dates of your vacation. This is limited to five consecutive days (one week) per family.

Holidays, Absence, Illness, Vacations, Inclement Weather

No refunds will be made for Holidays, Absence, Illness, Vacations, or Inclement Weather. You pay for your reserved spot, not attendance.

Change in Program/Withdrawals from Program

A two-week written notice of any change or withdrawal from programs is required. In the event of suspension from the program resulting from behavior problems, the tuition will remain the same.

Illness/Good Health

Should a child become ill during the day, it will be necessary to pick him/her up as soon as possible. Any Child with a contagious (infectious) disease cannot return to school without a release from a physician. Up-to-date medical forms, including blue immunization forms are due before the first day of school as required by the state.

Release of Child

Children will only be released to those persons whose names I have listed on the enrollment form unless the office is advised in writing by legal parent or guardian.

Emergency Care

The Director (person in charge) at Kiddie College has my permission to obtain necessary care (at my expense) in the event of sickness or accident if my Physician or I cannot be reached.
